INFORMATION AND INSTRUCTION

PURPOSE:

The purpose of the Hispanic Bar Association of Pennsylvania Legal Education Fund ("HBALEF") and its scholarship program is to assist Hispanic law students enrolled in law schools located in the Commonwealth of Pennsylvania and the Delaware Valley.

ELIGIBILITY:

HBALEF scholarships are available on a competitive basis to individuals of Hispanic background. The eligible applicants must be enrolled at an accredited law school located in the Commonwealth of Pennsylvania and the Delaware Valley during the fall of 2006 and the spring of 2007. Application for or receipt of a scholarship in a prior year will not disqualify an applicant in the current year. Although not a condition for a scholarship award, successful applicants are encouraged to contribute to the HBALEF after completing law school and securing employment.

AWARD AMOUNTS:

Each scholarship is traditionally for one thousand two hundred fifty dollars (\$1,250.00).

APPLICATION PERIOD AND DEADLINES:

All applications **MUST** be postmarked on or before **Thursday, September 28, 2006**, to ensure consideration. Applications cannot be submitted electronically. No late or incomplete applications will be accepted or considered. If an acknowledgment of receipt is desired, please enclose a self-addressed stamped envelope. Please note all students are required to submit a color photograph of themselves, approximately 3 inches by 5 inches, with the application documents. The photograph should be a head and shoulder or portrait style shot. Photographs of the selected scholarship recipients will be published in the program book for the HBALEF Banquet, as in prior years.

SELECTION:

Scholarship recipients are selected by HBALEF Selection Committee which is comprised of board members and directors of the HBALEF. The HBALEF reserves the right to change its criteria for awarding these scholarships without notice. Applicants will be notified only if they are awarded a scholarship. The scholarships will be awarded at the HBALEF Banquet taking place at the Independence Visitor Center in Philadelphia, Pennsylvania on October 12, 2006. Scholarship recipients are expected to attend the HBALEF Banquet as guests of the HBALEF.

The Personal Statement is an important and mandatory part of this application. Accordingly, it should be addressed solely to the HBALEF Scholarship Selection Committee. Personal Statements addressed to other institutions or selection committees will not be accepted.

- 10. Submit a current resume.
- 11. If you are not a first year student, submit an official copy of your law school transcript. First year students must submit a letter from the Registrar, or other documentation confirming enrollment for the 2006-2007 academic year.
- 12. Submit a copy of the application for financial aid that you supplied to your law school for the 2006-2007 academic year. **In addition**, please submit a copy your Free Application for Federal Student Aid (FAFSA) form or CSS/Financial Aid Profile form for the 2006-2007 year.
- 13. Complete and submit the attached Statement of Income and Expenses for the 2006–2007 academic year.
- 14. Submit a portrait style (head and shoulder) color photograph of yourself. It should measure approximately 3 inches by 5 inches.

Note: Failure to submit ALL documents and materials identified in items 9 through 14 above, will result in the rejection of the student's application from consideration.
